### 2025 Theme: Sustaining Equal Justice for Families & Communities

This year's theme focuses on legal initiatives that address pressing challenges faced by families and communities, ensuring their long-term stability and resilience. Special emphasis will be placed on:

- Strengthening Civil Rights Protections:
   Efforts to safeguard the constitutional rights of families and individuals through litigation, policy advocacy, and community legal education.
- Legal Representation for Families in Crisis:
   Advocacy to prevent family separation and
   unnecessary incarceration, ensure access to
   justice in child custody disputes, and support
   survivors of domestic violence.
- Community Justice Initiatives:
   Legal efforts aimed at addressing housing insecurity, access to healthcare and education, and preventing discriminatory practices that marginalize communities.
- Empowering Vulnerable Populations:
   Pro bono work that amplifies the voices of underrepresented groups, advocates for policy reform, and seeks to dismantle systemic barriers to justice.
