The 2023 National Appellate Defender Training (ADT) will offer an intensive, four-day virtual learning experience.

ADT is designed specifically for attorneys who represent indigent defendants in criminal and delinquency appeals in the state and federal court systems. This national skills training brings together court and appellate public defenders at the state and federal levels, assigned counsel, contract defenders, and Criminal Justice Act private attorneys for a multi-day program.

ADT objectives: 1) To assist appellate defense advocates in writing and delivering quality appellate briefs and writs, to improve the quality of appellate advocacy in the United States Supreme Court and other state and federal courts, 2) To provide a supportive national community for state and federal appellate advocates. This is the only appellate defender conference in the nation where participants work on their own real cases, not just hypothetical problems.
